

# Key Information Document

## Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

## Product

The product you purchase is a limited partner's interest in SHS VII Healthcare Investments GmbH & Co. KG (the "**Fund**", LEI: 5299000XMPTGK1K5B590). The manufacturer is SHS Gesellschaft für Beteiligungsmanagement mbH (the "**Manager**"). The website of the Manager is <https://www.shs-capital.eu/>. Call +49 7071 9169-0 for more information. The Federal Financial Supervisory Authority (*BaFin*) is responsible for supervising the Manager in relation to this Key Information Document. The Manager is registered in Germany and regulated by the Federal Financial Supervisory Authority (*BaFin*). This Key Information Document was prepared on April 16, 2026.

**You are about to purchase a product that is not simple and may be difficult to understand.**

## What is this product?

**Type:** The product is a limited partner's interest in the Fund.

**Term:** At least 10 years from the date of the final closing of the Fund plus an extension option of two times one year and thereafter, with the approval of a qualified majority of investors, for successive one-year extensions. The Fund is a so-called closed-end fund. This means that the interests cannot be returned or sold to the Fund by the investor upon request. Cancellations of the participation in the Fund are also excluded - except in the cases prescribed by law. Cancellations of the participation in the Fund by the Manager are possible under the special circumstances provided for in the limited partnership agreement.

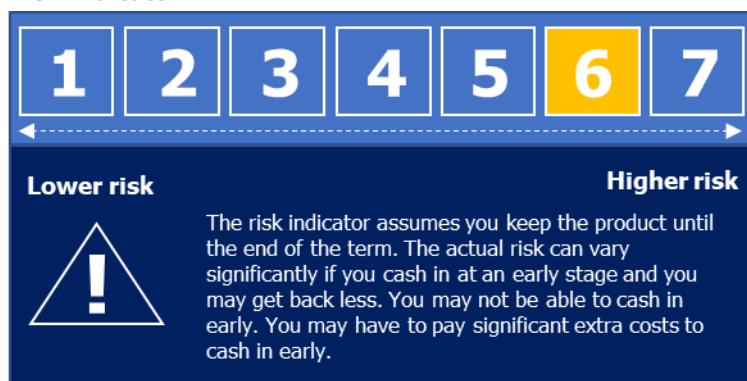
**Objectives:** The objective is to increase the capital invested by the investors during the term of the Fund. To this end, the Fund acquires companies and makes investments in companies at the growth stage. To this end, equity and quasi-equity investments and other investment objects are acquired, held and sold. The investment focus is on the lower middle market, *i.e.*, in enterprises that have generated revenues of at least EUR 10,000,000 in the twelve months preceding the date of the relevant investment. The Fund invests in portfolio companies which originate mainly from the DACH region (Germany, Austria, Switzerland), the Benelux states (Belgium, Netherlands, Luxemburg) as well as Denmark, Finland, Iceland, Norway and Sweden and are operating in the healthcare sector and in healthcare-related assets and businesses, with a primary focus on Medical Technology & Supplier, Pharma & Supplier, Diagnostics & Tools, and Health Technology. The Fund allows for discretionary choices in regards to investments that are to be made, whereby this approach does not include a reference to a benchmark. Returns that exceed the costs incurred are generally returned to the investors or paid out to the Fund's initiators via carried interest. A portion of the returns (including any dividend income) may be reinvested. The return of the Fund depends on the performance of the investment assets held and the appropriate time of acquisition and disposal.

**Intended retail investor:** Qualified investors within the meaning of Regulation (EU) No 345/2013. The statutory minimum capital commitment is EUR 100,000. This Fund is suitable for you if you are pursuing the goal of general asset accumulation or asset optimisation and would therefore like to add private equity to your asset portfolio as a high-yield supplement. The Fund is further aimed at investors who have knowledge of, and experience with, private equity funds, can hold the product for the long term and can cope with a total loss of their investment.

## What are the risks and what could I get in return?

### Risk Indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product in risk class 6 out of 7, which is the second highest risk class. This rates the potential losses from future performance as "high" and poor market conditions are very likely to impact our capacity to pay you.

This product cannot be cashed in. If you exit the investment earlier than the recommended holding period you may have to pay extra costs.

### What happens if the Manager is unable to pay out?

There is no contractually guaranteed payout. According to the provisions of the limited partnership agreement, investors will participate in the returns generated by the Fund. If the Fund has to file for bankruptcy, losses would be likely for the investors. A default of other companies (general partner or managing limited partner), on the other hand, does not lead directly to financial losses for the investors, but can (temporarily or permanently) impair the Fund's ability to act. A possible loss is not covered by a compensation or security system for investors.

### What are the costs?

### How long should I hold it and can I take money out early? Recommended and required minimum holding period: 10 years

The product is a limited partner's interest in a closed-end fund. The investment should be held for the entire term of 10 years plus an extension option of two times one year and thereafter, with the approval of a qualified majority of investors, for successive one-year extensions. An early withdrawal of money is generally not possible. Also, the sale of the limited partner's interest is not possible without the consent of the Manager.

<sup>2</sup> This illustrates how costs reduce your return each year over the holding period. For example it shows that if you exit at the recommended holding period your average return per year is projected to be 7,5 % before costs and 6.4 % after costs.
